The Electro Homoeopathic Medical Association of India (E.H.M.A.I.) State Council Regulations

1 Short Titles, Extent and Commencement

- These Regulations may be called Electro Homoeopathic Medical a) Association of India State Council's Regulations.
- b) It shall extend to whole of the State.
- It shall come into force with effect from the establishment of State Council c) of the respective State.

Definition 2

In these regulations, unless there is anything repugnant in the subject or context.

Establishment of Council

The Electro Homoeopathic Medical Association of India (E.H.M.A.I.) has resolved to establish State Council in the following manner which shall comprise the following:

- Two (2) Members to be nominated / elected amongst the Practitioner a) member of the State.
- One (1) Member to be nominated / elected amongst the course b) conducting institutions of the State.
- c) One (1) Member to be nominated / elected amongst the Instructional institutions of the State.

- d) One (1) Member to be nominated / elected amongst the Medicine Processing units of the State.
- e) One (1) Member to be nominated / elected amongst the Medicine Sellers of the State.
- f) One (1) Member to be nominated / elected amongst the Teacher's of the Electro Homoeopathic institutions of the State.

4 Chairman & Vice Chairman

- There shall be a Chairman, who shall be nominated by the E.H.M.A.I.
- There shall also be a Vice Chairman who shall be elected by the members of the State Council.

5 Terms of Office of the Member

The terms of office of a member (including Chairman& Vice Chairman) shall be Five Years from the date of his nomination/election as a member.

6 Resignation

- The Vice Chairman or any member may at any time resign his office by a letter to the Chairman of the State Council, such resignation shall take effect from the date on which it is excepted by the Chairman or State Council, if so referred to by the Chairman.
- ii) A Chairman of the State Council wishing to resign may forward written resignation to the E.H.M.A.I. resignation of the Chairman shall take effect from the date on which its acceptance by National Council of E.H.M.A.I. is notified.

7 Vacancies in the office of a Chairman/Vice Chairman/Member

If a member or Chairman/ Vice Chairman dies or resigns or due to any other cause what so ever, ceases to be member or Chairman / Vice Chairman, as the case may be, the vacancies so cleared shall be filled by a fresh nomination/election as the case may be for the remaining period of time of the member, Chairman/Vice Chairman.

In the case of a nominated/elected members, if the vacancy for less than six (6) months shall be left unfilled for the residuary term.

8 Removal of Members

The State Council and /or E.H.M.A.I. may remove a member:

- a) If, He during the period for which he has been nominated/elected absence himself without sufficient cause from Three (3) consecutive ordinary meetings of the councils.
- He has been sentenced by a court to imprisonment for an offence involving moral turpitude.
- c) He is an undischarged insolvent.
- He has been adjudged by a competent authority to be of unsound mind.
- Have appeared in any suit or proceeding, civil or criminal against the State Council or against the interest of the Electro Homoeopathic Medical Association of India. (E.H.M.A.I.)

9 Duties of Chairman / Vice Chairman / Secretary

A) CHAIRMAN

- The Chairman will preside over all the meetings of the State Council.
- To control and supervise the activities of State Council.
- To superintend and control the financial, executive and administrative offences.

To perform such other duties as are required imposed by E.H.M.A.I. by the resolution passed accordingly.

B) VICE CHAIRMAN

- i) A Vice Chairman shall in the absence of the Chairman from a meeting of the council and Unless prevented by reasonable cause preside as per regulations and conduct the business, maintain and in force order at the meeting during vacancy in the office of the Chairman or the incapacity temporary absence of the Chairman.
- ii) The Chairman may empower by ORDER the Vise Chairman to exercise under his control any one or more of his Powers, duties or functions subject to any conditions, imposed or any restriction in respect of the exercise of which power, the performance of any duty or discharge of any function.

C) SECRETARY

- i) The State Council with the prior approval of the E.H.M.A.I. shall appoint a secretary who shall be Executive Officer of the State Council, who shall conduct all official correspondence under his signature.
- He shall convene all meetings of the Council on due dates and give intimation thereof to the members in time.
- He shall prepare the agenda of a meeting under the direction of the Chairman.
- iv) He shall maintain all the income and expenditure accounts and keep the documents properly.
- v) He shall submit the report of the working of the Council in every meeting.
- The secretary shall open Bank account and operate as per resolutions passed by the State Council.
- vii) He shall sign and authenticate all the documents of the State Council.

10 Meeting of the Council

The State Council shall meet at the office of the Council or such other place, at such time in such a manner as may be decided by the Council.

No business shall be transacted at any meeting in which at least One third (1/3) members are not present.

Provided that a meeting postponed for want of quorum. The Chairman be adjourn to another date, and on the such date no quorum shall not required.

11 Chairman of Meeting

If at a meeting neither the Chairman nor the Vice Chairman is present, the members present shall elect one of their member to be the Chairman of the meeting and such Chairman shall perform all the duties and may exercise all the powers of the Chairman of the Council when presiding at the meeting.

12 Decision by Vote

- All questions which may come before a meeting of the council shall be decided by a majority of the votes of the members present and voting.
- In case of an equality of votes, the Chairman of the meeting shall have a a casting vote.

13 Minute Book and Resolutions

- i) The names of the members present and the proceeding held and resolution passed at a meeting of the Council shall be entered in a Book Called The Minute Book.
- ii) The minutes shall be read out at the meeting or the meetings and after being passed as correct by the members present at the time of reading shall be verified and certified as passed under the signature of Chairman of the the meeting at which they are passed.
- iii) A copy of the proceeding of every meeting of the council shall, within fifteen (15) days from the date of the meeting be forwarded to E.H.M.A.I. or any other authority appointed by E.H.M.A.I. in this behalf.

14 Powers of the State Council

The State Council shall have the following powers namely:

- To issue membership certificates to Electro Homoeopathic Practitioners and Medicine Selling Centers in the prescribe manner.
- To recommend for approval of Electro Homoeopathic Educational or instructional institutions.
- To recommend for approval of Electro Homoeopathic Course conducting institutions.
- To recommend for Certification of Electro Homoeopathic Medicine Processing Units.
- To recommend Research Work(s) to the Government.
- To invite any person(s) who will be helpful in the fulfillment of affairs of the Council.
- The State Council shall demand and receive such fee in such manner from the members as may be prescribed by E.H.M.A.I.

15 Dissolution of State Council

If at any time it appears to E.H.M.A.I. that the State Council has failed to exercise or perform a duty imposed upon and/ or One third (1/3) Members, resign. the E.H.M.A.I. may dissolve the State Council.

OBJECTS & REASONING

The Electro Homoeopathic Medical Association of India (E.H.M.A.I.) has decided to decentralize their functions and duties at the state level because Health and Education in Our Country is controlled by the State Governments and the Law & Order situation are also mostly controlled by the States.

The Central Government by its ORDER vide No C.30011/22/2010-HR Dated 21-06-2011 passed in furtherance of the Hon'ble High Court Judicature at Allahabad Lucknow Bench; Lucknow in WP.No 3992/2004 (Electro Homoeopathic Medical Association of India V/s. State of U.P. & 4 ors.) Has been kind enough to direct all the State Governments/UTs of the country to follow the same and render necessary action in that regard.

Hence, The Electro Homoeopathic Medical Association of India thinks it just and proper in the interest of Promotion and Development of Electro Homoeopathic System of Medicine to form State Councils.
