## **OBJECTS**

#### **Duration: 4 + 1 years Programme**

(4 years Theory & 1 year Internship)

#### Introduction:

The Board of Electro Homoeopathic Medicine, U.P. is a holder of Government Order passed and issued by the Uttar Pradesh Government, Department of Medical-6 on 4<sup>th</sup> January, 2012 and the same was circulated by the Directorate General of Medical & Health Services-U.P. for implementation to All Additional Directors Medical Health & Family welfare along with all C.M.O(s) of Uttar Pradesh on dated 14-03-2016.

In the compliance of Orders dated 10<sup>th</sup> December, 2014 and 3<sup>rd</sup> August, 2016 issued by Department of Medical Education-2 vide No 4510/71-2-14-writ- 122/2014 and as per office Memorandum Department of Ayush-1 vide No 1297/71-Ayush-1- 2016- W-283/2014 dated 03 August 2016 respectively. The existing courses needed some changes to update.

So new course namely G.E.H.S. is framed for Statutory provisions to fulfill the norms and Upgrade Electro Homoeopathic Course.

#### Eligibility:

Any person passed 12th standard or equivalent examination with Science (Biology) are eligible for this course. Candidates passed M.B.E.H. Course can take admission direct in Final Year.

#### Session:

This course will commence from April every year.

#### **Subject of Course:**

The course consists on the following subjects:

#### G.E.H.S. 1st Professional

Anatomy - 2 Papers, Physiology (including Biochemistry) - 2 Papers, Pharmacy and Philosophy.

#### G.E.H.S. 2nd Professional

Pathology (including Micro Biology) - 2 Papers, Forensic Science & Toxicology, Materia Medica and Practice of Medicine - 2 Papers.

#### G.E.H.S.3rd. Professional

Obstetrics & Gynecology - 2 Papers, Ophthalmology including E.N.T. - 2 Papers, Environmental Science and Materia Medica.

#### G.E.H.S. Final Professional

Materia Medica& Therapeutics, Practice of Medicine - 2 Papers, Surgery and Physical & Health Education,

#### P.G.E.H.

#### (Post Graduate in Electro Homoeopathy)

Duration: 2 years Programme

G.E.H.S. or Graduate in any Medical Stream, Candidates passed M.D.E.H. Course can take admission direct in 2<sup>nd</sup> Year.

#### Introduction:

The Board of Electro Homoeopathic Medicine U.P. started **F.M.E.H.** course in the year 1977 which was conducted as direct examination, within a short span of five years, it became as a regular course and it is also taught in affiliated institutes of the Board.

In present era of Globalization and medium of Open and Distance Learning, Board has decided to launch this course in Open Schooling System also. The duration of the course will be two years which comprises of four semesters.

#### **Eligibility:**

Any person passed 12th standard or equivalent examination any stream can take admission in this course.

#### **Subject of Course:**

The course consist on the following subjects:-

#### a) First Semester

Anatomy, Physiology, Pharmacy, Philosophy.

#### b) Second Semester

Pathology, Hygiene & Health, Environmental Science.

#### c) Third Semester

Ophthalmology including E.N.T., Medical Jurisprudence & Toxicology, Dietetics.

#### d) Fourth Semester

Obstetrics & Gynecology, Materia Media, Practice of Medicine.

### (Advance Certificate in Electro Homoeopathy) [Equivalent to Post Certificate]

**Duration: One Semester Programme** 

#### **Introduction:**

The Board of Electro Homoeopathic Medicine, U.P. has decided to launch a short term Course for the practitioners of various branches of Medicine which may practice authoritatively in Electro Homoeopathy as well as to benefit their patients with Electro Homoeopathic System of Medicine.

#### Eligibility:

Practitioners registered / enlisted in any state Board in any branch of medicine or person(s) having qualification not less than two years in Electro Homoeopathy or course of other branch of medicines like Vaidya Visharad, Ayurveda Ratan, D.A.M., D.U.M. and Fazil-E-Tib. etc. from known organizations/institutions whether functioning or ceased their activities on or before 30th April 2004.

Candidate having paramedical certificates of same duration and having authority to use medicines can also take admission in this course.

Enrollment form should be supported with an affidavit attested by an Oath Commissioner or Public Notary.

#### Session:

#### **Subject of Course:**

The course consists on the following subjects:-

- 1) Anatomy & Physiology
- 2) Pharmacy-Philosophy & Materia Medica
- 3) Pathology-Hygiene and Health & Medical Jurisprudence and Toxicology
- 4) Midwifery & Gynecology, Ophthalmology & Practice of Medicine

#### C.E.H.

(Certificate in Electro Homoeopathy)

**Duration: Two Years Programme** 

Introduction:

The Board of Electro Homoeopathic Medicine, U.P. has has launched a two years programme for the students to work as an Assistant to Electro Homoeopathic Hospitals/Doctor's/Dispensaries/Pharmacies as a Pharmacist.

#### Eligibility:

Any person passed 10th standard or equivalent examination can take admission in this course.

#### Session:

This course will commence from April & October every year and exam will be conducted annually.

#### **Subject of Course:**

The course consists on the following subjects:-

#### First Year:

Anatomy and Physiology, Introductive Study of Electro Homoeopathic remedies, Clinical Pathology, Health Education and Community Pharmacy, Drug Chemistry of Electro Homoeopathy.

#### Second Year:

Pharmacognosy, Pharmacology and Jurisprudence, Hospital & Clinical Pharmacy, Drug Store and Management, Drug Chemistry of Electro Homoeopathy.

#### Guide

Any person interested to pursue course under the distance learning mode, then this will be done under the supervision and guidance of a Registered Practitioner of the Board of Electro Homoeopathic Medicine, U.P. / Member of Electro Homoeopathic Medical Association of India (E.H.M.A.I.) or a group of practitioners.

List of registered practitioners of the Board of Electro Homoeopathic Medicine, U.P. / Member of Electro Homoeopathic Medical Association of India (E.H.M.A.I.) is available on Board's website www.behm.org.in.

A registered practitioner of Allopathic, Ayurvedic, Unani and Homoeopathic systems are also authorized as a guide which qualifications includes in the schedule of the Medical Council Act. 1956, Central Council of Indian Medicine Act. 1970 and Central Council of Homoeopathy Act. 1973 or (any amendment takes in his place) and registered with their respective council's. The guide should have experience of minimum 5 years.

Any individual practitioner can guide maximum 10 students at a time, whereas a group of practitioners can do the same at a ratio of 1:15.

#### Oral Coaching/Clinical Training:-

Every enroll student will take Oral Coaching as well as clinical training and assistance in completion of assignment from their guide in duration of this programme. The duration of Coaching / Training will be 3 to 4 hours on daily basis or at least 360 hours in a semester.

#### Contact Pragramme/Practical Training:-

Ten days contact Programme / Practical Training is compulsory in each semester. The complete schedule of contact Programme / Practical Training will be communicated to enroll student during the course of time or will be upload on website.

#### Fee:

The admission fee, Tution Fee, Enrollment Fee and Examination Fee etc. of the above courses will be charged by the affiliated institutions/authorized study centres as decided by the Board, except Enrollment and Examination Fees the Institutions/Study Centersmay charge as per their convenience.

Enrollment Fee and Examination Fee should be paid through Bank Draft infavour of the Board of Electro Homoeopathic Medicine, U.P. Payable at Lucknow.

Fee once paid shall not be refundable and/or transferable.

#### **Examination:**

The Board of Electro Homoeopathic Medicine U.P. generally conducts the examination four times in a year (for Semester Courses); it will be held in the month of March, June, September and December.

#### Medium of Examination:

Generally medium of examination will be English. The candidate can give Answer in English/Hindi/Urdu or any regional language with the prior permission of the Board.

#### Result:

The Result of the Examination will be declared after two months from the examination. The result will be published in the official gazette and/or upload on website.

#### Mark sheets & Certificate:

Those Candidates who will appear in the examination through any other Centre themark sheet and certificate will be dispatched directly to the successful candidates.

#### **Registration Certificate:**

The Registration certificate for Electro Homoeopathic practice will be issued on request. The registration application form can be down loaded from the website or obtain from the Board's office.

#### Facilities and Privileges to the Registered Practitioners:

The Registered practitioner is authorize to practice in Electro Homoeopathic System of Medicine in anywhere in India and abroad as per State Government Order.

#### ORDER

Subject:- Regarding practice, education and research in alternative system of medicine

An order was passed on 11.10.2010 by the Eucknow Bench of the Hon. High Court of Judicature at Allahabad in the WP No.3992/2004 filed before the Hon. High Court of Judicature at Allahabad at Lucknow Bench. in Electro Homeo Medical Association of India vs. State of UP & 4 Ors. as under:

\* Heard Learned counsel for the parties and perused the record.

With regard to it grievance, the petitioner may make a representation within a month from today in the Light of the Government Order dated 5.5.2010 (No.V.25011/276/2009-HR) issued by the Government of India, Ministry of Health & Family Welfare Department of Health Research.

If the representation made by the petitioner within the aforesaid period, the same shall be decided by the Government of India within three months from the date of its filing.

With above observation, the writ petition is finally disposed of."

- Consequently, in accordance with the said order, Sh. Taj All, Secretary, Electro Homeo Medical Association of India, Lucknow has filed a representation in the matter vide his letter dated 03.11.2010 in which he has made the following submissions and prayer:
  - That the order dated 25.11.2003 addressed to different officials and copies sent, however, to all their subordinates was mis-interpreted as if the Government of India has altogether prohibited the development and research of Electropathy, however the order dated 05.05.2010 has clarified that there is no proposal to stop the petitioner from practicing in electropathy or imparting education as long as this is done within the parameters of the order dated 25.11.2003 and once the legislation to recognize new system of medicine is enacted any practice or education would be regulated in accordance with the said Act.

On the basis of the order dated 25.11.2003 different authorities issued preventive orders as if there can be no teaching or practice in Electropathy/Electro Homoeopathy at all and that forced the applicant to file the above noted writ petition in the Hon'ble High Court Allhabad, Lucknow Bench, Lucknow. However in the meantime the order dated 05.05,2010 has clarified the position and the Hon'ble Division Bench in the light thereof has opined that now no detailed order is required to be passed and the petitioner may make the representation to the Government of India and Government of India may pass the order in the light of the order dated 05.05.2010.

It is, therefore, respectfully prayed that the authorities to whom the order No.R.14015/25/96-U&H(R)(Pt.) dated 25.11.2003 was issued, may kindly be communi-

cated to read the order in the light of the Government of India later order dated 05.05.2010 and act only in accordance with the same and may not cause any interference in contravention of the same."

- 3. As per the directions of the Hon. Lucknow Bench of the High Court of Judicature at Allahabad, the representation has been considered. It is clarified that the MH&FW Order No.R.14015/25/96-U&H(R)(Pt.) dated 25.11.2003 and No.V.25011/276/2009-HR dated 05.05.2010 would be treated as instructions of the Government of India related to practice, education and research with regard to alternative systems of medicine like electropathy, electro-homoeopathy, etc.
- 4. A copy of each of the said two orders viz. MH&FW Order No.R.14015/25/96-U&H(R)(Pt.) dated 25.11.2003 and No. V.25011/276/2009-HR dated 05.05.2010 is being forwarded herewith to each of the State Governments/UTs for information and necessary action. With this your representation is disposed off.

#### ORDER

The matter regarding grant of recognition to the various streams of alternative medicine . including electropathy/electrohomeopathy, has been under consideration of the Govt. In this process Govt, has considered the orders dated 18.11.98 of the Hon'ble High Court of Delhi in CWP. No.4015/96 & OM. NO.8463/97 which has inter-alia directed the Central/State Govts, to consider making legislation to grant of licenses to the existing and new institutes etc: to control & regulate the various 'unrecognised' streams of alternative medicines and also to give adequate publicity through media informing public about the 'Respondents' and similar other institutes not being recognized by the Covt. & affiliated with any of the Councils.

Government constituted a 'Standing Committee of Experts' under the Chairmanship of Director General, Indian Council of Medical Research and members were drawn from various fields of medicine to consider & give its recommendations to the Government on the efficacy/merits of various streams of alternative medicine and also examine feasibility of making legislation as suggested by the Hon'ble Court.

The Committee developed essential & destrable critical constitution of recognition to a new stream of medicine and analysed the different streams of 'Alternative medicine viz. Ayurveda, Siddha Unani, Hômocopathy, Yoga & Naturopathy, Electropathy/Electrohomocopathy, Acupuncture, magnetotherapy, Reiki, Reflexology, Urine Therapy/Autourine Therapy, Hypnotherapy, Aromotherapy Colour Therapy, Pranic Healing, Gems & Stone Therapy and Music Therapy.

The Committee did not recommend recognition to any of these alternative medicines except the already recognized traditional systems of medicines, viz: Avurveda, Siddha, Unani, Homeopothy and Yoga & Naturopathy which were found to fulfill the essential & desirable criteria developed by the Committee for recognition of a system of medicine. The Committee has, however, recommended that certain practices as Acupuncture and Hypnotherapy which qualified as modes of therapy, could be allowed to be practised by registered practitioners or appropriately trained personnel. Committee further suggested that all those Systems of Medicine not recognized as separate Systems should not be allowed to continue full time Bachelor and Master's degree courses and the term "Doctor". should be used only by practitioners of Systems of Medicine recognized by the Government of India, Those considered as Mode of Therapy can be conducted as Certificate courses for registered medical practitioners to adopt these modes of therapy in their practice, whether modein medicine or Indian Systems of Medicine and Homoepathy.

After carefully examining the various recommendations of the Committee, the Government accepted these recommendations of the Committee. Accordingly, it is requested that the State/UT Government give wide publicity to the decision of the Government any ensure that institutions under the State/UT do not grant any degree/diploma in the stream of medicine which have not been recommended for recognition and the term 'Doctor' is used by practitioners of recognized system of medicine.

However, the Order No. R. 14015/25/96-U & H(R) (pt) dated 25th November 2003, does not bar the Development & Research of Electropathy.

In accordance with Orders of the High Court & Supreme Court quoted here, there is no proposal to stop the petitioners from practicing in electropathy or imparting education, as long as this is done within the provision of the Order No. R. 14015/25/96-U & H (R) (Pt) dated 25th November 2008. Once the legislation to recognize new systems of meditine is enacted, any practice or education would be regulated in accordance with the said Act. The representation of the petitioner dated 28.10.2009 is disposed off accordingly.
